1. The Elmore county Classic will be under the direction of Bobbi Law (hogs), Alisha Elledge (sheep, steers and market heifers), and Amy Sage (Goat). The show chairman is Bobbi law.
2. Proper show ring attire is required and should follow standard 4-H or FFA guidelines. No open toed shoes, short pants, tank tops or shirts not covering the shoulder or midriff accepted.
3. There will be no refund of entry fees.
4. Sawdust pen bedding must be used.
5. Exhibitors are responsible for cleaning of pens before leaving the grounds; Failure to do so will result in forfeit of premiums.
6. The show manager will handle any problems, questions, and situations before, during or after the show that may arise covered or otherwise not covered by the printed rules. Any and all decisions will be at the discretion of the Show Managers, and will be final, and not subject to appeal.
7. There will be no late entry fee this year.
8. Show open to youth 2-19 years old as of January 1 of the current year.
9. All animals will be weighed, and classes will be set after completion of weigh-in.
10. Any hogs weighing 300 pounds and under are welcome. No maximum weight for market lambs, market goats, or market steers.
11. Check in and weigh in will be:  
Lamb and Goat: **Thursday** June 25th 6-8PM/**Friday** June 26th 6-8AM  
Steers/Market Heifers: **Friday** June 26th 6-8PM/**Saturday** June 27th 6-7AM  
Swine: **Friday** June 26th 6-8PM/**Saturday** June 27th 7-8AM
12. All animals will only be weighed once.
13. 100% of entry fees will go into the Jackpot.
14. A \$5 per pen fee is required by the Elmore County Fairgrounds.
15. All livestock from outside of Idaho must have proper health papers. Consult your veterinarian.
16. All animals must be free of diseases. We reserve the right to remove an animal because of health concerns.
17. Proof of ownership will be required at check in.
18. Exhibitors are responsible for the care and grooming of their own animals. We encourage parent assistance keeping in mind this is a Jr. Show.
19. ECC is a SRSC sanctioned show.
20. All exhibitors are encouraged to enter Showmanship. Prizes will be awarded for
